****28-2532A VEHICLE REGISTRATION:** (a) No fine if your registration was valid at the time of the ticket, show proof to the court; or (b) \$209.00 if renewed registration shown to court; or (c) \$646.00 if registration not renewed; or (d) No fine if the defendant was an operator but not the owner of the motor vehicle, trailer or semitrailer. Show proof to the court.

****** 28-4135A-C VEHICLE INSURANCE: Must appear in Court**

(a) No fine with proof shown to court that your insurance was valid ON DATE AND TIME COMPLAINT WAS ISSUED; Effective September 30th, 2009; (b) Fine may be reduced to \$241.00 with 6 months of valid insurance; including a print out from MVD showing that the Defendant has not been found responsible of a violation of A.R.S § 28-4135 within the past 24 months OR has not had more than one violation of A.R.S. § 28-4135 within the past 36 months as evidenced by the Defendants driving record. (You can obtain a copy of your driving record at MVD or visit www.servicearizona.com) (c) \$1100.00 If no insurance shown and a three month suspension of driving privileges & vehicle registration.

*******28-4139A SUSPENDED REGISTRATION PLATE:** (a)

\$375.00.00 if reinstated vehicle registration and MVD receipt shown to court; or (b) \$656.00 if registration not reinstated; or (c) show proof from MVD to court if suspension is an MVD error.

+ 28-3169A, 28-2158 DRIVERS LICENSE OR VEHICLE

REGISTRATION NOT IN POSSESSION: (a) Fine can be suspended with proof of registration valid ON DATE AND TIME COMPLAINT WAS ISSUED. Driver's license may be dismissed, (b) \$257.00 if no proof.

+++RED LIGHT VIOLATIONS:

IMPORTANT NOTICE: If you are responsible for a Red Light Violation, A.R.S. §28-645A3A, you will be subject to a court fine and the Arizona Motor Vehicle Department will require you to attend a Traffic Survival School (TSS). However, if you are eligible for the Defensive Driving Class (DDC), as explained on page 2, you will not be subject to the court fine and additional MVD sanction.

NOTICE TO JUVENILES

1) Juveniles charged with civil traffic violation(s) only, may choose any option on page one. 2) Juveniles charged with criminal traffic violation or misdemeanor offenses must appear in court in person with a parent/guardian; 3) Juveniles who admit to, or are found responsible for, a moving traffic violation are subject to separate administrative action by the Motor Vehicle Division which may include attendance at traffic survival school (TSS) or suspension of driving privileges

DEFENSIVE DRIVING CLASS (DDC)

You are eligible for the Defensive Driving Class if:

- A. You have not attended within the last year. (violation date to violation date); and
- B. You **do not** contest your ticket; and
- C. You were cited for a moving civil violation not involving serious injury or death; and
- D. If an asterisk (*) is listed next to the violation on page 5.
- E. You do not have a commercial driver's license.

INSTRUCTIONS FOR ATTENDING DEFENSIVE DRIVING CLASS (DDC)

- 1. **If you choose to attend this course, you must:** Complete the course before your court date. Your court date is located on your ticket.

- 2. **DO NOT CALL THE COURT.**

- 3. You may only attend an Arizona Supreme Court certified school. To register call **1-888-334-5565** or visit the website:

- 4. Have your ticket and a pen or pencil with you when you call to schedule a class. You will need to write down instructions for attendance as well as give important information on your ticket to the person registering you.

- 5. **The offender shall complete the course at least seven days prior to the court arraignment day or extension date. (DO NOT PAY THE CITATION)**

- 7. Payment in full must be **received or postmarked** before your court date, or extra fees must be added.

- 8. If you are late in a civil traffic violation, a \$20 late fee, \$10 collection fee and a \$35 default fee must be added. If you are unable to pay the amount in full, you must arrange a payment schedule prior to your court date.

- 9. If you request a payment plan, you must add an additional \$20.00 time, payment fee and \$10 Collection fee.

We must receive your request for a hearing **before** the court date. You will then be notified by mail of your trial date. **Setting a hearing will result in the loss of the privilege to attend defensive driving class for violation dismissal.**

If you are required to pay fines, penalties, fees or other financial obligations as a result of a judgment of this court and you are unable to pay, bring this information to the attention of the court staff or the judge because payments over time or other alternatives may be available. Do not ignore your responsibility to pay, as this may result in additional penalties and costs to you. For more information, contact the court or an attorney.
